Welcome to the Neighbourhood Team's first newsletter for schools.

We are keen to share information with you all about current trends and challenges that are affecting our communities, and invite feedback from parents about the issues that matter the most to you and your children, as well as offering advice on how to manage issues at present.



Did you know that it is **illegal** to ride a privately owned electric scooter (e-scooter) in public? 

That's because e-scooters are classified as motor vehicles by law. So, in theory, this means that you need an MOT, road tax and insurance to use one. However, it is not currently possible to register e-scooters in this way.

The statistics for e-scooter accidents in the UK reveal a pattern of increasing casualties, particularly during the summer months. In 2023, there were 1,387 recorded casualties among e-scooter riders and pedestrians, including six fatalities.

Privately owned e-scooters can only be used on private land, with the permission of the landowner.

You cannot use a privately owned e-scooter on a road, pavement or in a public space. If you do, then you risk having your e-scooter seized and destroyed, face a large fine and even points on your driving licence! Should you not currently hold a license, these points can be added in the future once you obtain your license.

Some parts of the UK are running government trials of rental e-scooters. If you are over 16 and have a full or provisional driving licence, then

you can rent these and use them on public roads and cycle paths (Just check that your driving licence covers categories AM, A or B).

We are urging our community to stay alert to a dangerous social media trend known as the **door-kicking challenge**. This viral TikTok trend involves individuals—often teenagers—kicking or banging on doors late at night or in the early hours, filming the act for social media. This behaviour has been reported across the UK and even internationally, including in the USA.



Important Reminder:

Even if no theft or burglary occurs, this is still **illegal**. It's classed as **anti-social behaviour and vandalism**, and can lead to **criminal charges**. More seriously, it can be mistaken for an attempted break-in, potentially triggering defensive or dangerous responses from residents.



Parents & Guardians:

Please speak with your children about the risks and consequences of participating in trends like this. What may seem like a prank can cause real harm, fear, and long-term impact—especially for vulnerable individuals and families. Do you know what your kids get up to when outside the home?



The Neighbourhood Policing Team is working closely with local schools and communities to identify those involved. Anyone caught will receive a more formal visit from **Thames Valley Police**.

If you have young children:

- Never let them go trick or treating on their own.
- Make sure you accompany them and only visit people you know.

If you have teenagers:

- Make sure they don't have access to fireworks, alcohol, eggs or flour.
- Explain why they must not play tricks on strangers.
- Tell them that if nobody answers the door, or a 'No trick or treat' sign is on display, they must leave immediately.
- Remind them to stay with their friends and make sure they know that they should never enter the home of a stranger

Shortly after Halloween we have celebrations of November 5th. Bonfire night is one we would all like to "remember, remember", but for the right reasons, and not the wrong ones.

It is vital that no one under the age of 18 has access to fireworks, so please ensure your children stay away from these for the safety of everyone. On the evening of bonfire night, the time in which fireworks can be set off is no later than midnight. Please respect these times to ensure everyone in the local community can enjoy this occasion in their own ways.
